For more than 100 years, we have been blessed to come alongside these human service agencies, community councils and community-based organizations as they find a way to strengthen thriving in challenging economic times. Please receive our Annual Report and see how last year’s Campaign metamorphized into an investment in more than 60 life-enhancing programs, projects and organizations that make a difference one person at a time. I highlight our United Way/2-1-1 ALICE Program, working with the Human Services Coalition, that was able to distribute almost \$95,000 in up to \$500 increments for an acute need such as rental assistance or car repairs. While such assistance does not guarantee economic stability, UWTC believes that by providing such support, we are conveying the message to each household that “You matter and you belong!” Indeed, as Robin Wall Kimmerer says, “All flourishing is mutual.”

Economic times are challenging at the personal level. At the national level, food insecurity and homelessness are on the increase. Health care access needs are growing. Charitable giving is affected in these times as well. So, we rejoice for your continued and steadfast generosity that helps to create the village that makes our area one of the best in which to live in the United States. 

2023-24 CAMPAIGN RESULTS


Per Donor Choice Selection





SUCCESS STORY

Ellen*, a young single mother of 2, benefited from the support of multiple UWTC Impact Partners and programs. Ellen started her journey within the UWTC impact network with **The Learning Web**. She was able to qualify for an expedited Housing Choice Voucher which enabled her to have her own home for her and her children. Ellen was coming out of an abusive relationship and had difficulty maintaining work due to a lack of transportation and childcare. To help empower Ellen to deal with these challenges, she was referred to multiple other UWTC Impact Partners. For support regarding her abusive ex-boyfriend, she worked with **Advocacy Center**. To help her secure childcare, **Child Development Council** paid for her deposit at **Ithaca Community Childcare Center**, which was able to offer her scholarships for her children. When she was unable to pay her rent portion due to being out of work, Ellen was referred to **Legal Assistance of Western NY**, who was able to work with her landlord to help her avoid eviction. She also received rental assistance through the **United Way/2-1-1 ALICE Program**. The Learning Web also helped her get her driver's license. Now, Ellen is working consistently while her children attend a high quality child care center.

Youth & Philanthropy Program (YAP)

This program provides high school students firsthand knowledge of community needs and resources, guides them through a competitive grant process, and helps them learn the impact of philanthropy. The funding distributed to grant recipients has been provided by Triad Foundation for many years.

\$3,000 Foodnet Meals on Wheels: Let it Snow! Blizzard Bag Program
Funds were used for the distribution of Blizzard Bags to vulnerable older adults in Tompkins County. Four packaged, shelf-stable meals are packed into a reusable bag for easy distribution and important and relevant handouts are inserted to help foster a greater awareness within the community about food insecurity and malnutrition among older adults.

\$1,200 Youth Farm Project: Farm Shares - Fresh Food for Families
Funds supported the Farm Share program, which gives teens and their families a weekly share of produce from the farm to bring home. The Farm Shares are free to the youth and include a variety of produce.

\$4,500 Ithaca Welcomes Refugees: Global Roots Play School Scholarships
Supported the scholarship program of Global Roots Play School, allowing for no and low income immigrant and refugee families access to high quality childcare.

\$4,000 Family & Children's Service of Ithaca: Open Doors for Runaway and Homeless Youth
Funds supported the Open Doors program which provides emergency crisis counseling for youth and families as well as emergency transportation and shelter for youths under the age of 21.

\$1,000 Community School of Music and Arts: Arts for All Accessibility Program
Funds were used to provide free or low cost access to visual, performing, and musical arts education to individuals and families who find CSMA's membership costs a burden or "out of reach" for them financially.

\$1,000 Family Reading Partnership: Books for Bright Red Bookshelves
Funds were used to buy new, high-quality, age appropriate children's books to put on the Bright Red Bookshelves. The Bookshelves provide free books for children to take home and keep in almost 50 locations in Tompkins County.

\$2,575 Finger Lakes Toy Library: Expanding STEAM offerings of the Finger Lakes Toy Library
Funds were used to expand the offerings of the Finger Lakes Toy Library's lending collection to include additional high quality STEAM (Science, Technology, Engineering, Arts and Math) toys for a wider variety of ages, and to offer STEAM specific play times throughout the year.

\$725 Free Science Workshop: Animal Health and Wellbeing at the Free Science Workshop
Supported the purchase of supplies for the care of the Free Science Workshop's "Animal Kingdom" animals. Youth are able to actively care for and learn about the animals while visiting the Free Science Workshop.

\$500 Human Services Coalition of Tompkins County: Youth Action Board (YAB)
Funds were used to support the Youth Action Board (YAB), which is composed of youth who have lived experiences with homelessness between the ages of 16 and 24. The Board's main goal is to ensure that the priorities of homeless youth are considered first in any decisions that affect their well-being.

\$1,500 YMCA of Ithaca and Tompkins County: Adaptive Aquatics at the Y Summer Swim Clinic
Funds supported a free, week-long swim clinic tailored to youth living with developmental disabilities. The goal of the program is to enhance aquatic safety and foster a profound sense of community belonging among these exceptional young individuals.

\$5,000 Catholic Charities Tompkins/Tioga: Transportation Assistance
Funds were used to address the urgent transportation needs of the most disadvantaged communities in our county, including car repairs, gas vouchers, and monthly bus passes, to individuals facing significant challenges in accessing reliable transportation.



SUCCESS STORY

I teach in the High School Branches Program at TST BOCES, which serves students with Intellectual Disabilities and/or Autism who require specialized support. Finding ways to provide valuable new experiences for our students without triggering major outbursts can be challenging, yet these experiences are crucial for their growth. Many of our students had never swam in a pool before, and some, like one of my students who uses a wheelchair, had never been in the water.

By partnering with the adaptive swim program funded by United Way, our students are bused to the Ithaca Y pool where they receive 1:1 swim instruction from dedicated and specially trained YMCA staff. YMCA adaptive aquatics staff members are not only exceptional role models but also work hard to build meaningful relationships with our students. For our kids, this opportunity is transformative. Students who had never swum before are now excited to visit the YMCA, eager to race to the pool and meet "their friend" who is teaching them. Students who were once fearful of strangers are now chatting with staff, sharing stories, and even looking forward to telling their swim buddies about their schoolwork. This partnership has made a significant difference in their lives, and I know I speak for all the staff and students at TST BOCES when I say, "Thank you for providing this incredible program."

FOCUS

Focus on Community & Understanding Service



This program for middle school students is held annually each spring to teach students about philanthropy, community needs, and to award grants to non-profit programs that are either in or serve the host community. Again in spring of 2023, United Way and Dryden Youth Opportunity Fund collaborated to host the program in Dryden under the co-leadership of Dryden Central School educator, Linda Bruno, and United Way's Director of Community Impact, Rebekah Hinton.

\$750 DRYDEN COMMUNITY DINNERS

(Fiscally sponsored by the Dryden United Methodist Church)

Dryden Community Dinners provide a "home cooked" meal for residents of Dryden and the surrounding rural area on Wednesday evenings. The meals also offer a chance for socialization as many guests are elderly and often live alone.

(Fiscally sponsored by Dryden Central School)
Dryden Family Meal Connection delivers food during the summer to families experiencing food insecurity within the Dryden School District.

\$317 SOUTHWORTH LIBRARY ASSOCIATION: GRAPHIC NOVELS FOR TEENS

Funds to expand the catalog of available young adult graphic novels in the library. Graphic novels help youth develop reading skills, visual literacy, and critical thinking skills and are currently the most popular teen book section in terms of circulation and interest.

2023-24 GRANT AWARDS

T. MERRELL SHIPHERD FLEXIBLE FUND

This fund was established to honor T. Merrell Shipherd, former Director of United Way of Tompkins County, who, throughout his life, worked to bring people together to find effective solutions to community challenges. The T. Merrell Shipherd Fund is periodically repurposed as to its focus and goals, but always supports to improve nonprofit organizational efficiency and collaborations such as service delivery joint ventures. In 2023-24 the fund provided financial support to address emergent needs in the nonprofit community, as well as new approaches to existing challenges.

SUCCESS STORY:

Thanks to the funding provided through the T. Merrell Shipherd Fund, the Community School of Music and Art was able to help this mother and daughter explore art and wellness together:

"I recently attended the free art and wellness workshops with my 7-year-old daughter. We had a wonderful time! My main motivation was to give my arts and crafts-loving kid an opportunity to get creative in a different setting and have a sense of wellbeing. Having a low-stakes setting with time, leisure, and materials to just play was perfect. We found it very meditative and inspiring to do more. The clinician was both lovely and encouraging. I was just going to be along for the ride, but in the end, I benefited just as much as my daughter. She is asking when we can go back. Thank you for making this program possible and we hope to see more workshops like this available!"

UNITED IN ACTION

UW/211 ALICE PROGRAM



This program, in collaboration with Human Services Coalition, addresses critical housing, transportation, childcare and medical expenses not covered by other existing programs. The program is facilitated by 2-1-1 operators with United Way then making payments of up to \$500 directly to vendors on behalf of the ALICE households. These payments help mitigate evictions, shut-offs, and cancellations for rent, utilities car repairs, car insurance. The program also helps participants access child care and coverage for emergent medical expenses not covered by insurance.

*ALICE is an acronym for **Asset-Limited, Income-Constrained, Employed** households who live below a "survival" budget threshold that is determined bi-annually by county.

In the 4th year of the program, outcomes outside of meeting these urgent needs include:

- This program— unique to UWTC—was shared with local United Ways around New York State at the 2024 Summer Statewide Conference and is being explored for duplication in at least three other NYS counties.
- The program has a proven record of mitigating evictions as it connects participants with HSC's housing specialist and other housing assistance programs.
- UWTC impact partners are keeping their services information more up to date with 2-1-1, strengthening the effectiveness of that community resource as well

VOLUNTEER TOMPKINS



Volunteer Tompkins, a collaboration with Cornell's Einhorn Center for Community Engagement, is an online volunteer management page utilizing the platform GivePulse. Local non-profit organizations can post their volunteer opportunities, and individuals looking for ways to give back to their community have a "one stop shop" to find those opportunities. Currently, Volunteer Tompkins has 35 local non-profits

affiliated with the page and able to post their volunteer needs. Cornell students, faculty, and staff are connected to these opportunities and we are currently expanding to connect businesses to the platform as well, thanks to a grant by Legacy Foundation, in order to boost these volunteer events to populations looking for ways to engage in community service.

UNITED IN ACTION

United Tompkins Impact Fund

Formerly Community Care Fund



Each year, awards are granted to local non-profit agencies and community councils that meet the guiding principles of the United Tompkins Impact Fund:

- A commitment at each level of work to respect, value, and champion each person as they are, including all their unique identities; demonstrated by a written non-discrimination policy adopted by the organization's Board of Directors.
- Programs will assist individuals who are Asset-Limited, Income-Constrained, Employed (ALICE) despite having an income level higher than the standard Federal Poverty guidelines.
- Programs will provide services supporting safe, affordable living conditions and/or wellness.
 - *Wellness pertains to both physical and mental health and addresses employment, childcare, food insecurity, substance abuse and addiction, as well as physical, mental, and emotional abuse.*
 - *Safe, affordable living conditions are defined as housing that does not utilize more than 30% of income, and has utilities to provide heat, water, and electricity and meets minimum standards for safety.*

Volunteer reviewers from across Tompkins County and professional staff, with the approval of the UWTC Board of Directors, award UTIF grants to local programs that can provide measurable, positive outcomes and that address identified priorities to meet community needs. United Way ensures that donor dollars are well-invested by tracking and measuring these outcomes.




UNsung HERO AWARD:

We are pleased to report that UWTC was once again issued a “clean audit,” with no material misstatements or internal control weaknesses– which is the highest opinion an independent auditor can issue.

Importantly, our audit showed that our campaign revenue versus fundraising dollars ratio is strong; for every \$1 spent on fundraising we raised \$34. Our management versus program ratios are also considered to be very healthy, and we refer you to the Organizational Budget chart on page 5 to illustrate this point.

You will notice the organization’s net assets decreased by \$101,690 this year after a gain of \$89,886 the year prior. This change in position is due to a combination of fewer campaign dollars raised – an understandable trend being felt throughout the nonprofit sector during these challenging economic times – and our continued commitment to get as many resources as possible out to our community as possible. For example, in order to meet community need, the UW/211 ALICE Program continued despite requiring \$27,000 more in funding than the year prior.

Moving forward, we are pleased to report a robust start to the 2024-25 annual campaign. We also plan to continue to diversify our revenue streams through grants and earned income. Our budget for the new fiscal year draws down less from our investments, leaving them to grow.

We trust the clean audit opinion issued by Sciarabba Walker, the outcomes shared in this annual report, and our commitment to achieving a strengthened position as we move forward assure you as donors and community members that UWTC is practicing strong fiscal management and achieving significant community impact with your gifts.
